GSU convention delegates elect officers and Defense Fund directors

Delegates, officers and staff gathered at the Cedar Park Lodge on Blackstrap Lake for GSU's biennial policy convention on March 20, 21 and 22, 2014.

The policy convention is the governing representative body of GSU. Its decisions are made by majority vote of convention delegates. Business of GSU, including resolutions submitted by members, elected officers and/or convention delegates, is considered at the biennial convention. Resolutions, policy statements and reports adopted by the convention delegates become the policy of GSU.

Viterra's divestitures to Richardson Pioneer, CPS/Agrium, and Federated Co-op necessitated several changes to GSU's constitution and bylaws which were approved by convention delegates along with changes to the structure of the union's Joint Executive Council (board of directors). The amended bylaws and constitution are posted on GSU's web site at www.gsu.ca.

Changes in the structure of the membership base and Locals also lead to changes to the GSU's Defense Fund Board of directors. Convention delegates voted in favour of general secretary Hugh Wagner's recommendation that at least three Directors of the GSU Defense Fund should be members of Local 1 (Viterra Operations/Maintenance) or Local 2 (Viterra Head Office) or Local 14 (Richardson Pioneer) and/or Local 15 (Agrium | CPS).

Mike Carlin (Local 15), Ron Gerlock (Local 8), Mel McCormick (Local 1), Karen Morrison (Local 5), Dennis Piasta (Local 14) were elected as directors of GSU Defense Fund for a two-year term.

In order to keep the administration of the Defense Fund at arm's length from the administration of the union, Directors cannot be elected representatives on GSU's Joint Executive Council.

Elections were also held for the union's top officers. Delegates congratulated president Carolyn Illerbrun, vice-presidents Jim Brown and Michelle Houlden, and general secretary Hugh Wagner as they were elected and subsequently sworn-in for a twoyear term.

CLC delegates elect new president and secretary treasurer

On May 8 nearly 4,600 delegates to the 27th convention of the Canadian Labour Congress made history by electing a new president, Hassan Yussuff (Unifor) and defeating the incumbent, Ken Georgetti (USWA) in a very close race where the margin of victory was 40 votes.

Yussuff was previously the secretary treasurer of the CLC. His election as president marks the first time in the history of the CLC that an incumbent president has been challenged and defeated in an election.

"I think the election result in the contest for the CLC presidency reflects a desire for change to a more assertive and contemporary leadership profile at the head of the labour's national organization," said GSU general secretary Hugh Wagner. "GSU's elected leaders endorsed Brother Yussuff from the outset as we believe he is the right person who will bring what is required to get the job done."

CLC convention delegates also elected a new secretary treasurer, Barb Byers (SGEU and GSU), who is a familiar face to trade unionists in Saskatchewan and across the country. Byers had previously served the CLC as an executive vice president and before that as president of the Saskatchewan Federation of Labour. She was elected to her new position by a comfortable margin.

"GSU's elected leaders

also endorsed Sister Byers as we think she also brings what is needed to get the job done," said Wagner. "The labour movement in Canada has a lot of work to do to advance and defend the rights of working people whether unionized or not. Hassan Yussuff and Barb Byers will be key leaders in our struggle."

Marie Clarke-Walker (CUPE) was re-elected an executive vice president and Donald Lafleur (CUPW) was elected executive vice president for his first term, rounding out the executive leadership team of the CLC.

"We thank Ken Georgetti for his many years work and sacrifice on behalf of the labour movement," Wagner said. "All the best to him for the future."

CIRB decision maintains bargaining and representation rights

On April 17 the Canada Industrial Relations Board (CIRB) issued a unanimous decision confirming the continuation of the collective bargaining and union representation rights of employees working for Richardson Pioneer at the ten Saskatchewan locations acquired from Viterra. The CIRB decision was in response to an application by the employer to alter and potentially eliminate the bargaining and representation rights of the employees who had transferred to Richardson Pioneer on May 1, 2013.

"When the employer applied to the CIRB, GSU said its first priority was to defend the transferred employees' rights. That's what we did and we are very pleased with the outcome," said GSU general secretary Hugh Wagner. "We look forward to continuing our work with the employees at the ten unionized locations and we invite Richardson Pioneer employees at the nonunion locations to examine the clear benefits of union representation."

(Continued from page 1.) GSU's 2013 audited financial statements were reviewed in detail as was the draft annual report of the Joint Executive Council. Both documents were approved and are available to members on the GSU web page and at upcoming membership meetings.

Delegates voted to work to defeat of Bills C-377 and C-525, and they voted to further provide financial support to the Saskatchewan Federation of Labour in its Supreme Court challenge of the provincial government's 2008 amendments to the Saskatchewan Trade Union Act and imposition of essential services legislation.

GSU legal counsel Ronni Nordal led delegates through a workshop on handling grievances, and GSU staff rep Steve Torgerson led a twotiered workshop on how to conduct yourself in meetings and the necessity of social media awareness.

GSU's scholarship program was reviewed and convention delegates voted to change the deadline for receipt of scholarship applications. The change allows GSU's scholarship committee to choose scholarship recipients prior to the summer months and get the scholarship monies into the hands of the successful applicants prior to the start of the autumn semester. "We appreciate the GSU members and officers who took time away from their workplaces and families to attend convention," said general secretary Hugh Wagner. "It's important for representatives of the Locals to get together to chart our course for the next two years. Their input keeps the work of the union relevant to the members and ensures we are doing what the members want done."

The next GSU policy convention will be held prior to the end of May in 2016. In the meantime, GSU's Joint Executive Council is responsible for governing the union between conventions.

Local 8 (AEA/GSU) members vote to accept tentative agreements

Local 8.101 - Regina

Members of AEA/GSU Local 8.101 held a special meeting May 12 and voted to accept the terms of a tentative bargaining settlement reached with Advance Engineered Products on May 8. The previous collective agreement expired on October 31, 2103. Bargaining meetings with the Company were held in every month following expiry.

The bargaining situation was complicated by the Company's initial insistence that an important benefit known as attendance credits be severely curtailed or removed from the collective agreement altogether.

The Company's March 19 announcement of massive layoffs, slated for mid-May, had a chilling effect on the bargaining as attention shifted to the welfare of members facing layoff.

The situation changed again in April as layoff notices for

63 employees at the Regina Plant were rescinded and the prospect of layoff was pushed back to mid-July. Meanwhile, the agreement renewal bargaining plugged along as the AEA/GSU bargaining committee did its best to overcome obstacles to reaching a reasonable settlement.

On May 8 the Company removed the last impediment to a settlement and a tentative agreement was reached.

Local 8.102 - Saskatoon

On May 8, members of AEA/ GSU Local 8.102 met and voted to accepts the terms of a tentative bargaining settlement reached with Advance Engineered Products earlier that day.

Members had rejected an earlier final offer which didn't provide for accrual of attendance credits for future employees.

The previous collective agreement expired October 31,

2103, and there were numerous negotiation meetings with the company leading up to and following the expiration date.

The bargaining situation was complicated by a variety of issues, including the company's initial insistence that an important benefit known as attendance credits be severely curtailed or removed from the collective agreement altogether.

The company's March 19 announcement of the closure of the Saskatoon operation and mid-May layoffs for all employees, changed the focus of negotiations to workplace adjustment issues.

The focus of negotiations changed again on May 1 when the company advised the Local executive that there were talks around a joint venture involving the Saskatoon operation and facility.

On May 8 the company removed the last impediment to a settlement and a tentative agreement was reached.

It is a pre-eminent meeting place of decision makers involved in all aspects of the transportation supply chain from the west coast of Canada to the Great Lakes. WESTAC was founded in 1973. GSU has been a member since 1978.

Don McMorris, Government of Saskatchewan; Capt. Kevin Obermeyer, Pacific Pilotage Authority; John Salt, Canadian Tire; Robin Silvester, Port Metro Vancouver; Pat Sinnott, Consolidated Fastfrate; and Steve Whitney, Canadian Pacific.

"WESTAC is a forum where we are able to engage with key transportation industry leaders while representing the issues of GSU members," Wagner said.
