that the following amendment to GSU's constitution be submitted to GSU's 2020 annual membership meetings:

“That sub-section 5.15 of GSU’s constitution be amended by designating the current eight paragraphs to be sub-section 15.5 (a) and by adding the following new sub-section 15.5 (b).

15.5(b) *In the event of a vacancy in the office of general secretary, the Joint Executive Council (JEC) shall have the authority to appoint an interim general secretary and shall also have the discretion to establish an ad hoc recruitment and nominating committee (RNC) comprised of five representatives from the JEC. Once established, an RNC will be responsible for obtaining expressions of interest from prospective candidates for election to the office of general secretary at the next policy convention of GSU.*

An RNC shall have the authority to determine the qualifications required of candidates for the office of general secretary and to advertise for expressions of interest within and outside the membership of GSU.

In order to be an eligible for nomination to the office of general secretary candidates will be required to submit applications and agree to be interviewed as well as being subject to a screening process conducted by an RNC.

Only candidates nominated by an RNC will be eligible for election to the office of general secretary by the delegates to a GSU policy convention."
