The last update in August was a while back but since then your Local 1 Board of Delegates and Local 2 Executive Board have

been working to get information in members' hands, set bargaining dates and prepare bargaining proposals.

Bargaining Dates

We currently have 3 sets of dates agreed to for bargaining.

- November 16 & 17, 2022
- November 24 & 25, 2022
- December 14 & 15, 2022

In preparation for negotiations, your bargaining committees will be meeting on November 8, 2022. Once each set of dates has passed we will send out an update to all members.

Member Information

Your elected Local representatives have been passing along questions and concerns they are hearing and in response, we have been sending out information about the bargaining process, talking to customers, etc.

So keep chatting with your elected representative who sits on the Board and keep talking with each other at work. Communication is important.
